






Local, national footprint

 Existing bio-supply chain relationships in place with thousands of local hospitals

BCA's independent blood centers manage the collection, processing and storage of biological materials to supply on-demand to thousands of local hospitals using closed and automated collection, processing, testing and storage systems compliant with FDA regulations, incorporating quality management systems and data controls, integrated with IRBs, often under IND or BLA for hospital treatment and products in clinical trial or commercial distribution.











BCA centers generate >\$3B in annual revenue

managing >50% of the country's supply of blood and blood components

supplied to thousands of local hospitals

from 500+ facilities

operated by >70 members centers

in 43 states.

All accessible through one portal with potential to be under one master services contract with centralized support services such as contract management, site-onboarding, billing, and other support services.





For advanced therapies, BCA sites annually perform >10,000 cell therapy (autologous & healthy donor) collections + >20,000 therapeutic apheresis procedures on nearly 400 Optia devices at over 60 locations.

In addition to blood centers, BCA represents 16 Immunohematology Reference Laboratory (IRL) testing facilities in 13 states.








CVID-19 Response — A Case Study

Covid Convalescent Plasma CCP - BCA network collected & distributed over 75% of CCP in U.S.

- I. Negotiation lead for 80+ collection centers on cost recovery rate for funding of approximately 670,000 doses collected under EAP/EUA \sim \$556,000,000 includes testing equipment and over 38,000 invoices
 - During COVID-19 served as national operational center of collaboration, communication and coordination for all CCP collectors outside of ARC (American Red Cross)
 - Lead activities around: Obtaining IRB approval, supply chain management, resource sharing, invoicing/accounting, and data management of \$556M in BARDA/OTA Funding
 - Automated Reporting and Invoicing Process for 80+ independent collectors of CCP
 - Helped to strongly influence payment model so that it paid upon collection vs. distribution (alleviating the risk to the blood centers and helped to ensure blood centers did not have to negotiate hospital contracts)
- II. Developed PPE Supply Chain to support collections in COVID-19 Pandemic:
 - Helped industry collectors for all but ARC find sources for gloves, ear-loop masks, N95 masks, and other critical items for collecting in new environments
 - Supply chain bolstered to +100M in purchases giving leverage to distribution contracts for medical and lab consumables
